NOTIFICATION

No. 18413/A.—Whereas, Shri Sunil Chhatrapal Kedar, 49-Saoner Legislative Assembly Constituency, R/o Patansavangi, Tal. Saoner, Dist. Nagpur has been convicted under sections 406, 409, 468, 471, 120 (B), 34 of Indian Penal Code by the Court of Hon'ble 2nd Assistant Chief Judicial Magistrate, Nagpur (*vide* C.R. No. 101/2002) followed by an award of sentence of five years of rigorous imprisonment alongwith a total fine of Rs.12,50,000 on 22nd December 2023 ;

And Whereas, consequent upon the conviction of Shri Sunil Chhatrapal Kedar, Member of the Maharashtra Legislative Assembly, he stands disqualified for being a Member of the Maharashtra Legislative Assembly from the date of his conviction *i.e.* 22nd day of December, 2023 in terms of the provisions of Article 191 (1) (e) of the Constitution of India r/w section 8 of the Representation of the People Act, 1951.

Now, therefore, in accordance with sub-clause (a) of clause (3) of Article 190 of the Constitution of India, the seat of Shri Sunil Chhatrapal Kedar, Member of the Maharashtra Legislative Assembly has become vacant from the date of his conviction *i.e.* 22nd December, 2023.
