WHEREAS both Houses of the State Legislature were not in session;

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action further to amend the Maharashtra Public Universities Act, 2016, for the purposes hereinafter appearing and, therefore, promulgated the Maharashtra Public Universities (Amendment) Ordinance, 2022 on the 3rd Ord. VI of 2022. 10 August 2022;

> AND WHEREAS it is expedient to replace the said Ordinance, by an Act of the State Legislature; it is hereby enacted in the Seventy-third Year of the Republic of India as follows:-

1. (1) This Act may be called the Maharashtra Public Universities Short title and commencement. 15 (Second Amendment) Act, 2022.

In section 109 of the Maharashtra Public Universities Act, 2016 section 109 of (hereinafter referred to as " the principal Act "),—

- 3. (1) The Maharashtra Public Universities (Amendment) Ordinance, 20 Mah. Ord. VI of 2022 2022, is hereby repealed. Ord. VI of 2022.
 - (2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the corresponding provisions of the principal Act, as amended by the said Ordinance, shall be deemed to have been done, taken or, as the case may be, issued under the 25 corresponding provisions of the principal Act, as amended by this Act.

STATEMENT OF OBJECTS AND REASONS

Section 109 of the Maharashtra Public Universities Act, 2016 (Mah.VI of 2017), provides for the procedure for permission for opening new college or new course, subject, faculty, division or satellite center.

Sub-section (3) of the said section 109 provides for time limits for making application for grant of Letter of Intent for opening new college or institution of higher learning, grant of Letter of Intent by the Government, forwarding of compliance report by the University after scrutiny to the State Government and grant of final approval to open new college or institution.

Sub-section (4) of the said section 109 provides for the time limit for granting permission by the State Government to start a new course, subject, faculty, division or satellite center.

2. Some institutions in Aurangabad region have filed Writ Petitions in the Bombay High Court, Bench at Aurangabad objecting to some of the locations in the annual plan 2022-23 of the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad. The High Court has granted stay to the advertisement dated the 25th April 2022 issued by the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad regarding perspective plan for opening new colleges and also stayed issuance of Letter of Intent by the Government in such cases until further hearing.

In view of the said stay order, the Government has not granted Letter of Intent to the institutions for opening new colleges under the said University.

Moreover certain institutions, who claimed that their proposals meet the requirements, have made representations to the Government for considering their proposals. However, the Government could not consider such proposals due to expiry of time limits specified in the said section 109 therefor.

- 3. It was therefore, considered expedient to amend the said section 109, suitably, so as to extent the time limit for granting Letter of Intent and subsequent approvals for opening new colleges and new courses in the academic year 2022-2023.
- 4. As both Houses of the State Legislature were not in session and the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action further to amend the Maharashtra Public Universities Act, 2016, for the purposes aforesaid, the Maharashtra Public Universities (Amendment) Ordinance, 2022 (Mah. Ord. VI of 2022), was promulgated by the Governor of Maharashtra on the 3rd August 2022.
- 5. The Bill is intended to replace the said Ordinance by an Act of the State Legislature.

Procedure for permission for opening new college or new course, subject, faculty, division

(g) after considering the report of the university under clause (f), the State Government may grant final approval to such management as it may consider fit and proper in its absolute discretion, taking into account the State Government's budgetary resources, and other relevant factors, the suitability of management seeking permission to open new institution, etc. The final approval under this clause may be granted on or before 15th June, of the year in which such new college or institutions are proposed to be started. Such approval from the State Government shall be communicated to the university. Approvals granted thereafter shall be given effect by the university only in the subsequent academic year:

Provided however that, in exceptional cases and for the reasons to be recorded in writing any compliance report on the Letter of Intent, which is not recommended by the university, may be approved by the State Government.

Provided further that, with a view to extend the dates of making an application for seeking Letter of intent for opening a new college or institution of higher learning, scrutiny of application by Board of Deans and forwarding the same to the State Government, grant of Letter of Intent by the State Government, scrutiny of compliance report and forward the same to the State Government and grant of final approval by the State Government, for the academic year 2022-2023, the day or dates referred to in clauses (a), (c), (d), (f) and (g) of sub-section (3), as specified in column (2) of the Table given below, shall be read as provided in column (3) of the said Table :—

Provided however that, in exceptional cases and for the reasons to be recorded in writing any application not recommended by the university may be approved by the State Government:

Provided further that, with a view to extend the dates of, making application for seeking permission to start a new course of study, subjects, faculties, etc., scrutiny of the application by the Board of Deans and forwarding the same to the State Government and grand of permission by the State Government, for the academic year 2022-2023, the day or dates referred to in clause (a), (c) and (d) of sub-section (4), as specified in column (2) of the Table given below, shall be read as provided in column (3) of the said Table:—
