

L. A. BILL No. XXVIII OF 2025.

A BILL

*to authorise payment and appropriation of certain sums from and out of
the Consolidated Fund of the State for the services and purposes of the year
5 ending on the thirty-first day of March 2026.*

(As passed by the Legislative Assembly on the 21st March, 2025.)

WHEREAS by virtue of article 204 of the Constitution of India, it is
necessary to provide for the passing of an Appropriation Act for the appropriation
of certain sums from and out of the Consolidated Fund of the State for the
10 services and purposes of the year ending on the thirty-first day of March 2026;
and for the purpose of authorising payment of the said sums; it is hereby enacted
in the Seventy-sixth Year of the Republic of India as follows :—

1. This Act may be called the Maharashtra Appropriation Act, 2025.

Short title.

Withdrawal of Rs. 77,92,30,88,51,000 out of the Consolidated Fund of the State for the Financial Year 2025-2026.	2. From and out of the Consolidated Fund of the State, there may be paid and applied sums not exceeding those specified in column (4) of the Schedule hereto annexed amounting in aggregate to the sum of seven lakh seventy nine thousand two hundred thirty crores, eighty eight lakhs, fifty one thousand rupees towards defraying the several charges which will come in course of payment during the year ending on the thirty-first day of March 2026, in respect of the services and purposes specified in column (2) of the Schedule. 5
Appropriation.	3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the thirty-first day of March 2026. 10
