AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate Mah. action further to amend the Maharashtra State Board of Technical Education XXXVIII Act, 1997, for the purposes hereinafter appearing; and, therefore, Mah. promulgated the Maharashtra State Board of Technical Education Ord. II (Amendment) Ordinance, 2021, on the 2nd September 2021;

AND WHEREAS it is expedient to replace the said Ordinance by an Act of the State Legislature; it is hereby enacted in the Seventy-second Year of the Republic of India as follows:—

Short title and commencement.

- 1. (1) This Act may be called the Maharashtra State Board of Technical Education (Amendment) Act, 2021.
- (2) It shall be deemed to have come into force on the 2nd September 2021.

Amendment of section 26 XXXVIII of 1997.

In section 26 of the Maharashtra State Board of Technical Education Mah. of Mah. Act, 1997 (hereinafter referred to as "the principal Act"),—

XXXVIII of 1997.

(i) in sub-section (3), the following proviso shall be added, namely:--

"Provided that, for the academic year 2021-2022, such application shall be made on or before the 15th September 2021.";

(ii) in sub-section (4), the following proviso shall be added, namely:---

"Provided that, for the academic year 2021-2022, all such applications received within the prescribed time limit, shall be scrutinized by the Board and be forwarded to the Government on or before the 10th October 2021.".

Amendment of section 35 XXXVIII of 1997.

3. In section 35 of the principal Act, in sub-section (2), the following of Mah. proviso shall be added, namely :—

"Provided that, for the academic year 2021-2022, the management desirous of closing down the institution shall apply to the Board on or before the 15th September 2021.".

4. (1) The Maharashtra State Board of Technical Education Repeal of Ord. II (Amendment) Ordinance, 2021, is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken saving. (including any notification or order issued) under the corresponding provisions of the principal Act, as amended by the said Ordinance, shall be deemed to have been done, taken or issued, as the case may be, under the corresponding provisions of the principal Act, as amended by this Act.
