

**L. A. BILL No. XXVIII OF 2022.**

*A BILL*

*further to amend the Mumbai Municipal Corporation Act.*

**(As Passed by the Legislative Assembly on the 20<sup>th</sup> December 2022.)**

WHEREAS both Houses of the State Legislature were not in session ;

action further to amend the Mumbai Municipal Corporation Act, for the  
purposes hereinafter appearing ; and, therefore, promulgated the Mumbai  
Municipal Corporation (Second Amendment) Ordinance, 2022 on the 24th  
November 2022 ;

AND WHEREAS it is expedient to replace the said Ordinance, by an  
Act of the State Legislature ; it is hereby enacted in the Seventy-third Year  
of the Republic of India as follows :—

1. (1) This Act may be called the Mumbai Municipal Corporation  
(Second Amendment) Act, 2022.

(2) It shall be deemed to have come into force on the 24th November 2022.

Amendment  
of section 154  
of III of 1888.

**2.** In section 154 of the Mumbai Municipal Corporation Act ( hereinafter referred to as “the principal Act” ), in sub-section (1D), in clause (a),—

(i) in sub-clause (i), for the words and figures “and the year 2021-22” the words and figures “ , the year 2021-22 and the year 2022-23” shall be substituted ;

(ii) in sub-clause (ii), for the words and figures “and the year 2021-22” the words and figures “ , the year 2021-22 and the year 2022-23” shall be substituted ;

(iii) in sub-clause (iii),—

(a) for the words and figures “in the year 2022-23” the words and figures “ in the year 2023-24” shall be substituted ;

(b) for the words and figures “and the year 2021-22” the words and figures “ , the year 2021-22 and the year 2022-23 ” shall be substituted.

Power to  
remove  
difficulty.

**3.** (1) If any difficulty arises in giving effect to the provisions of the principal Act, as amended by this Act, the State Government may, as occasion arises, by an order published in the *Official Gazette*, give such directions, not inconsistent with the provisions of the principal Act, as amended by this Act, as may appear to it to be necessary or expedient for the purposes of removing the difficulty :

Provided that, no such order shall be made after the expiry of a period of two years from the date of commencement of this Act.

(2) Every order issued under sub-section (1) shall be laid, as soon as may be, after it is issued, before each House of the State Legislature.

4. (1) The Mumbai Municipal Corporation (Second Amendment) Ordinance, 2022, is, hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the corresponding provisions of the principal Act, as amended by the said Ordinance, shall be deemed to have been done, taken or, as the case may be, issued under the corresponding provisions of the principal Act, as amended by this Act.
