A BILL

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State for the services and purposes of the year ending on the thirty-first day of March 2024.

**(As passed by the Legislative Assembly on the 12th December 2023.)
(As returned by the Legislative Council without any recommendations
on the 12th December 2023.)**

WHEREAS by virtue of article 204 of the Constitution of India, read with article 205 thereof, it is necessary to provide for the passing of an Appropriation Act for the appropriation of further sums from and out of the Consolidated Fund of the State for the services and purposes of the year ending on the thirty-first day of March 2024; and for the purpose of authorising payment of the said sums; it is hereby enacted in the Seventy-fourth year of the Republic of India, as follows :—

1. This Act may be called the Maharashtra (Third Supplementary) Appropriation Act, 2023. Short title.
