  - 1. This Act may be called the Maharashtra National Law University Short title. (Amendment) Act, 2024.

#### STATEMENT OF OBJECTS AND REASONS

The Maharashtra National Law University, Aurangabad having its headquarter at Aurangabad is established under section 3 of the Maharashtra National Law University Act, 2014 (Mah. VI of 2014), with effect from the 27th June 2014.

- 2. The Government of Maharashtra has altered the name of revenue area "Aurangabad" and renamed as "Chhatrapati Sambhajinagar". In view of change in the name of revenue area "Aurangabad" as "Chhatrapati Sambhajinagar" it is considered expedient to substitute the name of "Maharashtra National Law University, Aurangabad" as "Maharashtra National Law University, Chhatrapati Sambhajinagar" and substitute the name of headquarter "Aurangabad" as "Chhatrapati Sambhajinagar" in the Schedule appended to the said Act.
  - **3.** The Bill seeks to achieve the above objectives.
