OVERVIEW OF MAHARASHTRA STATE

Maharashtra is located on the coast of the magnificent Arabian Sea and occupies the western & central peninsular region of India. BRIEF INFORMATION ABOUT MAHARASHTRA LEGISLATURE

History of the Maharashtra Legislature

The history goes as far back as 1832 or even earlier, when the Governor-in-Council made regulations to govern the Presidency. The history of the Legislature in Maharashtra is in essence the history of the Constitutional development of the India and the States comprising it since Legislature its character and function is an integral part of a Constitutional development. The Legislature as now understood and envisaged in the Constitution of India, does not merely enact laws - although it is one of its major functions, but does many more things such as passing the Budget, providing money by taxation and authorising its expenditure, and affording opportunities to the Legislators to exercise control and supervision over the Executive Government by way of criticism in a variety of ways on matters of administration.

The journey begins with a Government which did everything required for governance including passing laws to govern the people. The law-making a function of the Legislature and law enforcement a function of the Executive Government, the two together imply a great English Constitutional Principle namely; the Rule of Law, the foundation of which can be said to be truly laid for the first time in India by Mount Stuart Elphinston. For, it was Mount Stuart Elphinston who codified in 1827 the law (a monumental work) the regulations of the past 28 years and new ones till 1834, by which the Presidency of Bombay was to be governed.

The beginnings of the Legislature are to be found in the Council of the Governor which was gradually expanded both numerically and qualitatively by way of inducting experts like the Judges of the High Court, Advocate-General and Non-Officials drawn from amongst prominent publicmen. How this process went on can be indicated by the several enactments which followed.

Till the Charter Act of 1833, the Governor in Council of Bombay could make regulations and ordinances for the good Government of the factories or territories at first acquired in India, so, they be not repugnant to the laws and customs of the United Kingdom. These laws were known as regulations upto the year 1833. Under this Act, however, this power was withdrawn and vested in the Governor-General to make laws for the whole Country. Under the Charter Act, 1853, the Legislative Council as distinguished from the Governor-General's Executive Council was established. It consisted of 12 members namely; the Governor General, the Commander-in-Chief

and 6 Special members-the Chief Judge, 4 members of Executive Council, 1 Puisne Judge and 4 Representatives of the Provinces of Madras, Bombay, Bengal and North-West Province. The sittings of the Legislative Council were made public and the proceedings were regularly published. This proved to be a forerunner of the Legislative Council which came to be established for the Bombay Presidency under the Indian Councils Act, 1861. This was important in several respects.

Under this Act, Legislatures were constituted in Madras and Bombay in 1861, in Bengal in 1862, in North-West Province in 1866, in Punjab in 1897, in Eastern Bengal and Assam in 1905. These Provincial Legislatures consisted of four to eight members in addition to the Advocate-General of the Province, of whom half were non-officials to be nominated by the Governor. Rigid restrictions were placed upon the powers of the Legislative Councils. It was made obligatory to obtain previously the sanction of the Governor-General in Council for introducing certain legislative measures and bills passed by the Legislatures required the assent of the Governor-General, before they became Acts. Again they were not authorised to legislate on subjects like taxations, currency, post office, etc. The Governor-General thus constituted himself as the Head of all Legislative authority in British India.

This was followed by the subsequent Indian Councils Act of 1892 which liberalised the powers of the Legislative Councils and thus marked a further stage in the development of these bodies. The principle of nomination was still adhered to; but the nominated members in both the Central and Provincial Legislatures were nominated on the recommendations of various bodies, i.e. Chambers of Commerce, Provincial Legislature (for Central Legislature), local bodies, land holders, universities etc. It raised the maximum number of nominated representatives in the Governor-General's Council from 12 to 16 and in the case of Provincial Legislatures, the number fixed for Bombay and Madras was raised from 8 to 10. United Provinces received a Council of 15 members and the Punjab and Burma which then formed part of the Indian administration, were allotted nine members each. It also provided the right of asking questions after due notice, provided such questions were not argumentative, hypothetical or defamatory, No discussion was allowed on any reply, and the President of the Council reserved the right of disallowing any question. The right to discuss the budget was also conceded; but no member was allowed to propose any resolution or to ask the House to divide upon it. The budget was to be discussed as a whole and

not item by item. The Act, no doubt, widened the opportunities of non-official members for criticism, suggestions, remonstrance and enquiry.

Then came the Morley-Minto Reforms of 1909 which took the stage of development still further. The principle of elective representation was for the first time introduced in the Indian Councils. Two separate electorates were introduced whereby Hindus and Muslims were to be elected through their own separate constituencies. The chambers of commerce, land holders and other special interests were given direct representation. The general constituencies themselves were constituted out of Municipalities and the District Boards, but the important thing to be noticed was the acceptance of the principle of elective representation on the Councils. The maximum number of members fixed for the Central Legislature was 60, in the major Provinces like Bombay 50 and for the remaining 30. The councils were composed of officials, nominated non-officials and elected representatives. In all the Provincial Councils, the official votes were in minority, though the Government with the help of nominated members could in all provinces except in Bengal, out-vote the elected members. In the Central Legislature, Government had at all times a clear majority.

The powers exercised by the previous Legislatures were not only continued but were further augmented. The right to discuss the budget, which was conceded earlier, now included also the right to move resolutions on it. Resolutions embodying recommendations to Government on matters of general public interest were also allowed to be moved. The members thus gained wide opportunities for discussion on matters affecting the administration in general.

The advance made under the Act of 1909 was halting and incomplete in many respects, and the Indian opinion could not be satisfied with it. So, the next Act of 1919, called the Government of India Act, 1919 was passed by Parliament. This was preceded by the historic declaration of the 20th August 1917 by Mr. E. S. Montagu, the then Secretary of State for India which embodied the policy of the British Government in the matter of Constitutional development of India. The declaration is very important and can be rightly regarded as the real, beginning of the Parliamentary Government in India as envisaged under the Constitution of India, 1950. The declaration was in these terms :-

"The policy of His Majesty's Government with which the Government of India are in complete accord, is that of increasing the association of Indians in every branch of the

administration and the gradual development of self-governing institutions with a view to the progressive realisation of responsible Government in India, as an integral part of the British Empire. They have decided that substantial steps in this direction should be taken as soon as possible. I would add that progress in the policy can only be achieved by successive stages. The British Government and the Government of India on whom the responsibility lies for the welfare and advancement of the Indian peoples, must be guided by the co-operation received from those upon whom new opportunities of service will thus be conferred and by the extent to which, it is found that confidence cannot be reposed in their sense of responsibility. Ample opportunities will be offered for public discussion of the proposals which will be submitted in due course to Parliament."

An immediate result of this policy-statement, was the Government of India Act of 1919. The chief features of this Act were that direct elections were introduced in the Legislatures, The Central Legislative Assembly had a clear elected majority. The powers of the Legislative Assembly were considerably enlarged. Besides the right of moving resolutions and putting interpretations to Government, the Legislative Assembly was given the right to move adjournment motions to discuss urgent matters of public importance, and what was more important, was given an effective control over a large portion of the budget. Under section 25 of the Act, supplies were to be voted in the form of demands for grants and except for certain heads declared by the Government to be non-votable, the Assembly had in ordinary circumstances, control over the items presented to it for its approval.

The Central and Provincial subjects were earmarked : local Government, education, sanitation, public health, hospitals, asylums, public works, development of industries, agriculture, veterinary and co-operatives societies were provincial-transferred subjects, while lands, irrigation, famine, justice, police, prisons, factories etc. were the provincial reserved subjects. Other subjects were entrusted to the Central Government. In finance too a distinction was drawn; the Centre received income tax, railway receipts, posts and telegraphs, customs, salt tax, opium proceeds, while the provinces got land-revenue, excise, irrigation, forests, stamps and registration. This arrangement was known as Diarchy which meant that there were subjects which were entrusted to the care of popular ministers who were responsible to the Legislative Council and other subjects,

known as reserved subjects, which continued to be a special charge of the members of the Governor's Executive Council. This was, so to say, a popular Government in parts.

The strength of the Provincial Legislative Councils varied from 145 in Bengal to 40 in the North-West Province. Here also not more than 20 percent of the members of each Council were to be officials, and at least 70 percent of the members were elected.

The Provincial Councils much enjoyed larger powers than the Central Legislature in all matters except in Legislation. The legislative authority of the Provincial Councils was restricted in two ways by the previous sanction of the Governor-General in Council which was required in certain specific matters, and by the provincial character of the Acts passed by the Councils. The Governor, however, had the right of certifying, of voting or of reserving for consideration of the Governor-General, any bill passed by the Provincial Council. The Governor also had the power to withhold his assent for a bill with the result that the bill could not go on the Statute Book. The position under this Act though marked certain improvement in the way of Constitutional development, was still considered to be very inadequate since the power given to the popular elected bodies was incomplete in many respects and the Governor-General and the Governors continued to constitute the real authority in the administration of the Country.

Then came the Government of India Act of 1935 which envisaged a federal type of Government. It consisted of a Federation of the federating autonomous States including the Princely States. More power were given to the Central and State Legislatures and the control and interference of the Governor-General and the Governors was, to some extent, reduced. But the real substance of political power was still cluding the Indian people. The provincial autonomy in the States was successfully worked to some extent but as this Act could not satisfy the political aspirations of the Indian people, which demanded complete self-Government free from all external control, the Government of India Act of 1935 was never in its entirety put in operation. The parts relating to federation never came into operation. The Indian agitation continued for complete independence, and it came about in 1947 with the passing of the Indian Independence Act, which is a remarkably short piece of legislation transferring complete control of administration from the British hands to the Indian people. Subsequently the Constituent Assembly was elected and it framed the Constitution which finally came into being on 26th of January, 1950.

In regard to the State Legislatures, the relevant articles are contained in articles 168 to 178.

They in substance provide as follows :-

Every State Legislature shall consist of the Governor and in the State of Andhra Pradesh, Bihar, Jammu and Kashmir, Maharashtra, Karnataka and Uttar Pradesh, Two Houses and in other States one House. And of the two Houses wherever they are provided one shall be known as the Legislative Council and the other as the Legislative Assembly : and where there is only one House Provided, it shall be known as the Legislative Assembly. The Legislative Assembly of a State is empowered to pass a resolution to create a Legislative Council in a State where no Legislative Council exists or to abolish the Legislative Council where it exists, the majority required for this purpose is a special majority, of the total membership of the Assembly and of not less than two-thirds of the members present and voting. The Parliament is then enabled to pass the necessary legislation for the abolition or creation of the Legislative Council as the case may be. The Legislative Assembly of a State shall consists of not more than 500 and not less than 60 members, members being chosen by direct election from the territorial constituencies in the State. Article 333 provides for the representation of the Anglo-Indian Community in the Legislative Assembly. The same principles as in the case of Lok Sabha are laid down in regard to the territorial constituencies in the State and the seats allotted thereto. Similarly the same adjustment is provided following each census regarding the total number of seats in the Legislative Assembly and the division of the State into territorial constituencies.

The composition of the Council is somewhat different from the composition of the Council of States. The total number of members of a Legislative Council of a State shall not exceed one third of the total number of members in the Legislative Assembly of that State provided that the total number of members in the Legislative Council shall, in no case, be less than 40. The composition of the Legislative Council, is as follows :-

Nearly one-third of its members shall be elected by electorates consisting of local authorities : one-twelfth of members shall be elected by the graduates and another one-twelfth by teachers and still another one-sixth shall be nominated by the Governor, who have special knowledge in literature, science, arts, co-operative movement or social service. The remaining one-third shall be elected by the members of the Legislative Assembly of the State from amongst persons who are not its members.

Like the Lok Sabha every Legislative Assembly has a life of five years unless sooner dissolved. The qualifications for membership of the Assembly and the Council are almost the same as those in the case of membership of the two Houses of Parliament. The Governor also is similarly empowered to summon the Legislative Assembly or the Legislative Council as the case may be from time to time and is also empowered to prorogue them. He can likewise dissolve the Legislative Assembly. The Legislative Council is not subject to dissolution like the Council of States. It is also provided that not more than a period of six months shall elaps between two Sessions. The Governor is entitled to address either or both the Houses of Legislature assembled together and may for that purpose require the attendance of the members.

Ministers in the States and the Advocate-General, have right of participation in the proceedings of either House or its committees, although they may not be its members. Each House has also to elect two persons, the Speaker and the Deputy Speaker in the case of Legislative Assembly and the Chairman and Deputy Chairman in the case of the Legislative Council, the Speaker, as in the case of Lok Sabha, can continue in office even after dissolution until the first meeting of the re-constituted Assembly after the elections. The Ministers and members have to take oaths in terms prescribed before entering upon their office or taking seats in the House as the case may be.

As may be seen, the Council of States at the Centre and the Legislative Councils in the States are not directly elected by the people. They, therefore, do not possess the same powers especially in financial matters as the House of the People or the State Assemblies. The budget is presented to both the Houses, whether at the Centre or in the States, but demands for grants are not voted by the Council of States and the Legislative Councils. They can only discuss the budget generally without the right to vote upon it; but they have the right to consider the Appropriation Bill in the same way they can consider a money Bill. In the case of Legislation, the powers of the Council of States and the Legislative Councils are again restricted, as they cannot propose amendments to the money Bills as defined in Article 199 of the Constitution; and if they do not return the money Bills within a period of 14 days to the House of the People or the Legislative Assembly as the case may be, the Bills in question as passed by Lok Sabha or the State Assembly are deemed to have been passed. The Council of States and the Legislative Councils cannot also entertain any financial measure meaning, any Bill or amendment making provision for any of the

matters specified in sub-clauses (a) to (f) of Clause (1) or article 199. There are also similar restrictions on their powers, though less rigid, in the case of other Bills. Unlike in the State, in the Centre there is a provision for joint sitting of both Houses. When they cannot agree on the bills or the amendments.

"It is also necessary to mention that each house of Legislature, whether in a State or at the Centre has got the same powers, privileges and immunities as those possessed by the House or its members and Committees immediately before the coming into force of section 15 of the Constitution (Forty-fourth amendment) Act, 1978. In this case there is no distinction between Parliament and the State Legislatures, and they enjoy the same powers and privileges barring the difference mentioned above, the two Houses at the Centre and in the States have got the same powers in dealing with subjects committed to their care. It is also pertinent to observe that the lists have been carefully drawn up incorporating subjects respectively belonging to the Centre, and to the State known as the Union List and the State List and also subjects in what is known as the Concurrent List for which both the Parliament and the State Legislature are competent to Legislate. There are adequate provisions in the Constitution resolving a conflicts of jurisdiction arising in regard to legislation made on subjects in the Concurrent List. The Constitution contemplate that the Parliament and the State Legislatures should deal only with the subjects mentioned in their own Lists whether in the matter of legislation or otherwise.

Side by side it would be interesting to see over the years the several territorial changes that took place from the erstwhile Bombay Presidency to the present day Maharashtra. The Presidency of Bombay then consisted of 4 districts of Gujarat, 4 districts of Karnataka, 11 districts of Western Maharashtra and the Province of Sind. In or about 1949, the Princely States were merged in the existing adjoining districts of Maharashtra or new districts were formed and added, like Kolhapur, Sangli and Baroda.

In 1956, November, the States were re-organised on a linguistic basis, as a result of which a bigger bilingual State of Bombay was formed comprising all the districts of Maharashtra, 8 districts of Vidarbha from Madhya Pradesh, 5 districts of Marathwada from Hyderabad State, and all the districts of Gujarat together with the State of Saurashtra while taking away 4 Karnataka districts and joining them to the State of Karnataka. Subsequently, in 1960 the bilingual State of Bombay was bifurcated into 2 new States of Maharashtra and Gujarat. The Present State of

Maharashtra consist of 36 administrative districts - 10 districts of Vidarbha of the erstwhile Madhya Pradesh, 7 districts of Marathwada of the former Hyderabad State and the remaining 14 districts of Western Maharashtra. The State officially came into being on 1st May 1960, a historical occasion in the life of Marathi Speaking people, because it was for the first time that they were brought under one single homogeneous unit of administration.

Structure of Maharashtra Legislature

Maharashtra Legislature came into existence on 1st May 1960. The Legislature of Maharashtra consists of the Governor and the two Houses known as Vidhan Parishad (Legislative Council) and the Vidhan Sabha (Legislative Assembly).

Maharashtra Legislative Council

Among the oldest Legislatures in India, the Bombay Legislative Council held its first meeting on 22nd January 1862. Under the Government of India Act, 1935, the Bombay Legislature was formed, having two Houses. The Bombay Legislative Council first met on 20th July 1937 at the Council Hall in Pune. The monsoon sessions used to be held at Pune till 1955. This practice was discontinued. As per the Nagpur Pact, the winter session is held, generally, at Nagpur since 1960.

Members of the Maharashtra Legislative Council is a galaxy of great achievers. They represent the local self government, academicians, doctors, lawyers and jurists, writers and poets, music composers, the co-operative movement and agriculture.

The strength of the Council was 29 when it came into existence in 1937. It was raised to 108 in 1957 for the Bilingual State. After the State of Maharashtra was formed on 1st May 1960, the number came down to 78, which has been continuing.

Maharashtra Legislative Assembly

Under the Government of India Act, 1935, the Bombay Legislature was formed, having two Houses. The Bombay Legislative Assembly having 175 Members, first met on 19th July 1937 in Council Hall, Pune,

With the adoption of the Constitution of India on 26th January 1950, the Bombay Province Legislative Assembly came into existence. Article 170 of the Constitution provides for the formation of the Assembly. After the first Election of 1952, the Bombay State Legislative Assembly was formed. It was renamed as the Bombay Bilingual State Legislative Assembly in 1957 after the State Reorganisation and finally assumed the present name, the Maharashtra Legislature, after the Bilingual State was bifurcated into Maharashtra and Gujarat on 1st May 1960.

The Maharashtra Legislature, which came into existence on 1st May 1960 designated the then Assembly as the first House. Since then, elections to the Lower House have been held in 1962, 1967, 1972, 1978, 1980, 1985, 1990, 1995, 1999, 2004, 2009, 2014 and 2019. The present House, the 15th Assembly, has been formed after the election in 2024 having 288 members.

VIDHAN BHAVAN BUILDINGS IN MAHARASHTRA

COUNCIL HALL, PUNE

The first sitting of the Legislative Council and Assembly was held on 20th and 19th July 1937 respectively, at the Council Hall in Pune after the bicameral Legislature came into existence according to the Government of India Act, 1935. Similarly, the first sitting of the House was convened at this Council Hall on 10th September 1947 after India became independent. With the adoption of the Constitution and the first general elections held under it in January 1952 for the 316 seats of the Assembly, the session began at this Council Hall on 3rd May 1952. The Legislative Council and Assembly held 13 sessions at Pune till 1955.

OLD COUNCIL HALL, MUMBAI

The Sailors' Home constructed for accommodation of the sea-farers in 1876 was taken over by the Government in June 1928 and converted into the Council Hall. It was inaugurated by Governor Major General Sir Fredrik Sykes on 18th February 1929. In all 71 sessions were held in this building between 19th July 1937 and 25th April 1981.

NEW COUNCIL HALL, MUMBAI

Then Prime Minister Smt. Indira Gandhi inaugurated the present Vidhan Bhavan, Mumbai on 19th April 1981. The New Council Hall, Mumbai Legislature started its sessions in these premises from 25th April 1981. The sprawling structure is impressive and equipped with a beautiful Central Hall which is used for joint sessions and important functions.

COUNCIL HALL, NAGPUR

Maharashtra Legislature started holding its sessions at Nagpur Council Hall since 1960. Till 1956, Nagpur was the capital of Central Provinces and its Legislature used to meet at this Council Hall, which had been constructed in 1914. The first session of Maharashtra Legislature was held in Nagpur between 10th November and 16th December 1960.

The Council Hall complex was redeveloped in 1993. Then President Dr. Shankar Dayal Sharma inaugurated the new Assembly hall on 11th December, 1993. The House started its sittings there while the Assembly hall began to be used for the Council sittings.

‘Committee on Estimates’ of the Maharashtra Legislature:

A pillar of fiscal oversight and good governance

“Financial accountability is the soul of parliamentary democracy, and the Estimates Committee is its sentinel.”

The Parliamentary Committee system in India

The Parliamentary Committee system in India represents one of the most vital and enduring pillars of legislative governance, functioning as an indispensable mechanism for detailed scrutiny, institutional accountability, and informed decision-making. Rooted in the traditions of the Westminster model yet uniquely adapted to the Indian constitutional and political landscape, these committees operate as extensions of the Legislature, enabling more efficient and in-depth examination of complex legislative, financial, and policy matters than is typically possible in the full House. Parliamentary Committees—whether Standing, Financial, or Departmentally Related—play a transformative role in strengthening democratic oversight, ensuring executive accountability, and fostering bipartisan dialogue.

Through systematic inquiry, expert consultations, and rigorous analysis, they bridge the gap between the Legislature’s deliberative responsibilities and the administrative complexities of governance. The Committee system not only enhances the quality of legislative output but also embodies the principle of collective responsibility, transparency, and parliamentary control over the executive—thus reinforcing the foundations of India’s representative democracy.

Committee on Estimates in India

The **Estimates Committees in India** play a pivotal role in ensuring financial discipline, administrative efficiency, and accountability in governance. Established under Rule 310 of the Rules of Procedure and Conduct of Business in the Lok Sabha, the Estimates Committee is one of the three key financial committees of Parliament—the other two being the Public Accounts Committee and the Committee on Public Undertakings. Its primary mandate is to examine in detail the estimates presented to Parliament by various ministries, suggest economies in public expenditure, and ensure that funds are used effectively for the intended purposes. The Committee also evaluates the adequacy of policies and the implementation of programmes funded by the Union budget. Unlike the Public Accounts Committee, which scrutinizes past expenditures based on audit reports, the Estimates Committee adopts a forward-looking approach, often suggesting reforms in administrative procedures and budgeting practices. Comprising 30 members from the Lok Sabha, it functions as a non-partisan watchdog, submitting detailed reports that often lead to structural and policy-level changes in governance. Over the decades, the Estimates Committees—both at the central and state levels—have emerged as crucial instruments of parliamentary oversight, reinforcing the principles of fiscal prudence and democratic accountability.

The committee system of the Maharashtra Legislature

The committee system of the Maharashtra Legislature stands as a cornerstone of the State's legislative functioning, embodying the principles of accountability, transparency, and participatory governance. Modeled on the parliamentary traditions of the Indian Legislature, yet dynamically responsive to the specific administrative and political contours of Maharashtra, this system has evolved into a sophisticated institutional framework for legislative oversight. Legislative committees—whether financial, subject-specific, or procedural—serve as the Legislature's working arms, enabling closer scrutiny of governmental policies, budgets, and implementation mechanisms. These committees facilitate detailed deliberation beyond the limitations of time-bound plenary debates, allowing members to engage in rigorous examination, evidence-based recommendations, and cross-party dialogue.

By fostering informed decision-making, ensuring executive accountability, and refining policy outcomes, the committee system enhances the overall efficacy and credibility of the legislative process. It is through these committees that the Maharashtra Legislature not only asserts its constitutional mandate but also reinforces the democratic ethos of responsive and responsible governance.

Committee on Estimates of Maharashtra Legislature

The Estimates Committee of the Maharashtra Legislature occupies a crucial place in the state's legislative architecture, functioning as a key instrument for enforcing financial discipline and promoting administrative efficiency. Entrusted with the responsibility of scrutinizing the budgetary estimates placed before the Legislature, the Committee ensures that public funds are allocated and expended in a manner that is both economical and purpose-driven. By critically examining government spending patterns and resource utilization, the Committee not only guards against wasteful expenditure but also contributes to the evolution of a more transparent, accountable, and performance-oriented governance framework. Its recommendations often serve as valuable inputs for enhancing the effectiveness of public administration and refining policy implementation across departments.

Evolution and institutional significance of the Committee on Estimates of the Maharashtra Legislature

The Committee on Estimates of the Maharashtra Legislative Assembly has played a decisive role in shaping the fiscal oversight mechanisms of the State since its inception in 1951. Initially constituted with 15 members from the Legislative Assembly, including the Finance Minister, the Committee was designed to ensure detailed legislative scrutiny of budgetary estimates. The remaining 14 members were elected using the single transferable vote system, grounded in the principle of proportional representation. While the Finance Minister served as the ex-officio Chairperson, provisions were made for the temporary appointment of a Chairperson from among the members in instances where the Finance Minister was unable to attend a meeting.

Following the linguistic and administrative reorganization of Indian states under the States Reorganisation Act, 1956, the composition and structure of key financial committees, including the Estimates Committee and the Public Accounts Committee, were revisited. As a result, the membership of the Estimates Committee was expanded to 27, incorporating six members from the Legislative Council. The Finance Minister continued to serve as the ex-officio Chairperson under this revised structure. The election process remained unchanged, adhering to the single transferable vote system to ensure equitable representation. Reports prepared by the Committee were presented to the House either by the Chairperson or, in their absence, by another member, who would formally move for the report to be considered.

A landmark reform occurred in 1960, subsequent to the formation of the linguistic state of Maharashtra. Amendments to the Rules of Procedure of the Legislative Assembly led to a reduction in the Committee's size to 19 members—comprising 15 members from the Assembly and 4 from the Council. The method of election remained consistent with earlier practice. However, a pivotal change was introduced: for the first time, the post of Chairperson was assigned not to the Finance Minister, but to a non-ministerial member of the legislature. This transition marked a significant step in reinforcing the autonomy and parliamentary character of the Committee. From 1951 to 1960, successive Finance Ministers chaired the Committee. Mr. S.K. Wankhede, then Finance Minister, presented the 30th report in 1960, marking the end of this tradition. Thereafter, the Chairpersonship was entrusted to a sitting member of the Assembly, beginning with Mr. L.M. Patil (M.L.A.), who presented the 31st report in 1960. This convention has continued uninterrupted to the present day.

To facilitate thorough deliberation on subjects referred to it, the Committee was vested with the authority to summon individuals, demand official records, and requisition documents. These powers enhanced the Committee's ability to exercise oversight over administrative actions and financial planning. However, in order to streamline legislative proceedings and avoid procedural delays, formal discussions on Committee reports in the House were subsequently discontinued.

Between 1976 and 1978, the Committee undertook an experimental but significant initiative—**pre-budget scrutiny of departmental estimates**. In view of the increased workload, the Committee's strength was temporarily enhanced to between 19 and 29 members during this period. This allowed the formation of smaller, specialized sub-groups to conduct in-depth analysis of departmental demands. When the practice of pre-budget scrutiny was institutionalized as a permanent feature, the relevant rules were amended accordingly to accommodate a larger and more flexible committee structure.

Historically, members of major financial committees—including the Estimates Committee, the Public Accounts Committee, and the Committee on Public Undertakings—were elected through elaborate voting procedures. In a move toward efficiency and institutional reform, the authority to nominate members to these committees was conferred upon the Speaker of the Assembly. To uphold the democratic principle of proportional representation, the Speaker (or, in the case of the Legislative Council, the Chairman) was required to consult with the Leader of the House, the Leader of the Opposition, and leaders of recognized parties or groups before finalizing nominations. This ensured that political diversity within the Legislature was adequately reflected in the composition of these critical committees.

Rules 208, 209, and 210 of the Maharashtra Legislative Assembly, along with Rule 208 of the Maharashtra Legislative Council, contain detailed provisions regarding the constitution, powers, functions, and operational procedures of the Estimates Committee. These also provide for adequate representation of the Legislative Council within the Committee's framework, reinforcing its cross-house composition and collaborative legislative character.

Constitution of the Committee on Estimates

Rule 208 of Maharashtra Legislative Assembly Rules (12th ed. 2024)

- (1) As soon as may be after the commencement of the first Session of the Assembly in every year, or the first Session of a newly constituted Assembly as the case may be a Committee on Estimates shall be constituted to examine the budget estimates and the demands for supplementary grants and to suggest economies consistent with the policy underlying such estimates and demands and the form in which the estimates shall be presented to the Legislature.
- (2) The Committee on estimates shall consist of not more than twenty-nine members of whom not more than twenty-three members shall be nominated by the Speaker from among the members of the Assembly and not more than six members shall likewise be nominated by the Chairman from amongst the members of the Council.
- (3) The members of the Committee shall hold office until a new Committee is constituted.

Rule 208 of Maharashtra Legislative Council Rules (10th ed. 2024)

As soon as may be after the commencement of the first Session of the Council in every year the Chairman shall nominate not more than six members to represent on the Estimates Committee constituted under the Rules made by the Assembly.

Functions of the Committee on Estimates

Rule 209 of Maharashtra Legislative Assembly Rules (12th ed. 2024)

- (1) It shall be the duty of the Committee on Estimates—
 - (a) to scrutinise the budget estimates of expenditure in such detail as it may consider necessary and tender advice so as to ensure that Government's objectives are carried out in the most economical and efficient manner;
 - (b) to scrutinise the demands for supplementary grants in a like manner; and (c) to advise Government on any financial questions that may be referred to it.
- (2) The scrutiny of the budget estimates or the demands for supplementary grants by the Committee on Estimates shall not in any manner affect or postpone their consideration by the Assembly or its voting thereon. The Committee shall be entitled to scrutinise the budget estimates

or the demands for supplementary grants and tender advice notwithstanding that the Assembly may have already voted the grants comprised therein:

Provided that, the Committee shall not exercise its functions in relation to such public undertakings as come within the purview of the Committee on Public Undertakings under these Rules.

Powers and procedure of the Committee on Estimates.

Rule 210 of Maharashtra Legislative Assembly Rules (12th ed. 2024)

The Committee may hear officials or take expert evidence in connection with any matter under its examination. It shall be in the discretion of the Chairman of the Committee to treat any evidence tendered before it as secret or confidential.

Rules of procedure of the Committee of Estimates

(Internal Working)

In pursuance of the provisions of rule 184 of the Maharashtra Legislative Assembly Rules, the Estimates Committee of the Maharashtra Legislature, with the approval of the Speaker makes the following Revised Rules of Procedure to regulate its internal working:-

Rules of Procedure

1. The Committee will select from time to time a Department or group of Departments whose estimates are to be examined by them.
2. The Department or Departments whose estimates are to be examined by the Committee will be asked by the Secretary or any other officer of the Maharashtra Legislature Secretariat, to furnish necessary material in support of the estimates for the information of the Committee. The material to be furnished to the Committee shall be as in the accompanying form (**Appendix-I**).
3. The Departments concerned will furnish the requisite number of copies of the papers referred to in paragraph 2, to the Secretary, Maharashtra Legislature Secretariat, who will circulate them to the members of the Committee.
4. (i) The Committee may from time to time, appoint one or more Study Groups for carrying out detailed examination of various subjects.
 (ii) The functions of the Study Group shall be as set out in the Appendix (**Appendix-II**).
 (iii) The procedure in the Study Group shall, as far as practicable, be the same as in the Committee as laid down in the Maharashtra Legislative Assembly Rules.
5. The Study Group may make available to the Committee such of the tour notes, study reports and other reports or papers as it considers necessary.

6. The members will send their requests for further information if any, for the consideration of the Committee at least seven days in advance of the date of the meeting.
7. The members may, similarly, send their suggestions, if any, for the consideration of the Committee two days in advance of the date of the meeting.
8. If further information on the suggestions and points is called for by any member of the Committee, then the said further information should be supplied to all other Members along with information received from the Department.
9. On the date or dates the Committee meets to consider the estimates, the Secretary of the Department (Accompanied by other officers, if considered necessary) will attend the meeting to support the estimates and to furnish such information as the Committee may ask for.
10. The Secretary, Finance Department and the Secretary, Planning Department or a representative of each of those Department if permitted by the Chairman, shall attend meetings of the Committee to assist it in its deliberations.
11. When the examination of any part of the estimates has been completed the Committee may frame its recommendations.
12. Copies of the recommendations will be sent to the Departments and Officers concerned in accordance with the directions of the Chairman, for such action as may be necessary.
13. After consideration of the Statement of Action submitted by the Government, the Committee may make further recommendations, if necessary.
14. A record of the proceedings of each meeting of the Committee will be kept by the Secretary, Maharashtra Legislature Secretariat, who shall also note the points on which further information is required by the Committee for taking necessary action in consultation with the

APPENDIX-1

BUDGET ESTIMATES

Form of Questionnaire for calling information from the Ministerial Departments regarding particulars of the various grants forming the Budget Estimates, for the use of the Members of the Estimates Committee.

1. The organisation of the Department and its subordinate offices.

(The information should be shown in the form of a diagram supported by short explanatory notes).

2. The functions of the Department and its subordinate offices.

3. Broad details on which the estimates are based.
4. Works along with the schemes or projects included in the Five Year Plan which the Department has undertaken. While furnishing information in the records the name and details of the scheme, the estimate of expenditure, period within which it is likely to be completed, yield if any, obtained there from progress made to date, should be furnished. A Statement showing year to year expenditure incurred on each scheme or project for the preceding five years and the probables for the current year should also be furnished.
5. New items of expenditure, with explanatory notes.
6. Actual expenditure incurred under each sub-head of estimates during the preceding three years and reasons for variations, if any, between the actuals of the past three years and the current estimates.
7. Reports, if any, issued by the Department on its working.
8. Number of letters received and despatched during the last three years by each branch or section, as the case may be.
9. Any other information that the Committee may call for, or the Department may think it necessary or proper to give.

APPENDIX-II

Functions of the different Study Groups of the Estimates Committee

A. Study Groups dealing with a fresh subject:-

- (1) To study intensively the material supplied by the Department, etc.
- (2) To prepare the questionnaire to be issued after the approval of the Chairman to the Department etc.
- (3) To undertake study tours and prepare study notes thereof.
- (4) To indicate the broad points on which draft report may be prepared.
- (5) To discuss the draft report before circulation to the whole Committee.

B. Study Groups dealing with action taken by Government on earlier reports:-

- (1) To scrutinise replies received from Government.
- (2) To indicate points on which draft reports may be prepared.

(3) To discuss draft report before circulation to the whole Committee.

Bombay Stock Exchange-

The Modern multi-stories skyscraper near Flora Fountain which is the principal stock exchange of India where thousands of crore of rupees change hands everyday.



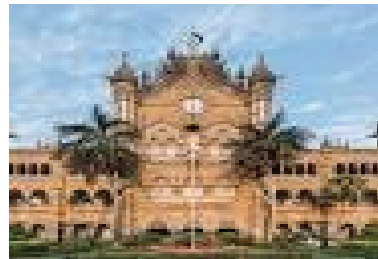
Horniman Circle-

A beautiful circle of stately buildings, it's an ancient monumental site near Flora Fountain, including the neo-classical Town Hall Housing the Asiatic Library and the central Library. A well maintained park forms the center of the round.



Chhatrapati Shivaji Maharaj Terminus (CSMT)-

Built in 1887, this is the city's most celebrated Gothic revival architecture, UNESCO World Heritage Site, and the Headquarter's of Central Railway, the largest and the most complex railway system in India, lavishly decorated with sculptures.



Marine Drive-

An esplanade in a sweeping curve it runs along the shoreline of the Arabian sea from Nariman Point to the foot of Malabar Hill. Perhaps the best known landmark in Mumbai, It's also called the Queen's Necklace and is at its beautiful best when light up in the evening. It stretches for about 6 kms. and is an ideal jogger's promenade, especially in early mornings.



Chowapatty Beach –

A neat and clean beach along with Marine Drive that comes to life when the sun goes down. Eating 'bhelpuri' and various 'chats' from the stalls is almost a ritual here.



Malbar Hill-

Winding uphill from Chowpatty you reach Malabar Hill, one of Mumbai's most posh residential areas. It offers a fantastic view of the Arabian Sea and the Queen's Necklace from a height. The Kamla Nehru Park and the famous Hanging Gardens are located here.



Haji Ali-

Not far from Malabar Hill is this beautiful massoleum situated at the culmination of a causeway jutting out into the Arabian sea. This is the tombstone of the famous Muslim saint Haji Ali' The Mosque can be reached only at low tide'

**Mani Bhavan-**

Mahatma Gandhi's temporary residence is now the Gandhi Museum house various artefacts concerning the Father of the Nation'

**Banganga-**

At Walkeshwar is this stepped up tank surrounded by 30 temples, 2 hermitages and several gymkhanas. The Banganga Tank in Mumbai's Walkeshwar is one of the city's oldest sites of worship. Its location on the main island of Bombay is evidence of the city's roots in Hindu mythology and folk tradition. Recent efforts to restore and culturally revive it offer a blueprint for incorporating Mumbai's pre-colonial heritage sites within its contemporary cityscape.



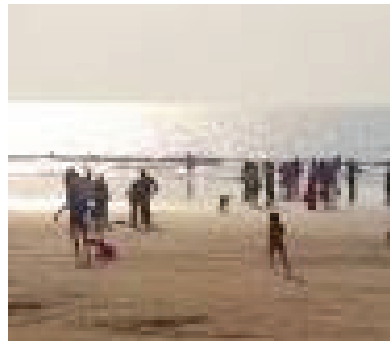
Veermata Jijabai Bhosale Udyan (Rani Baugh)-

Spread across an impressive ~60 acres, the Veer Jijamata Udyan, or the Rani Baug in Byculla, Mumbai, is one of India's oldest zoos.



Juhu Beach –

The famed seaside destination in the suburbs of Mumbai, it's a long stretch of sand well known for its carnival type of atmosphere, all with camel rides, horse rides, dancing Monkeys and shooting galleries. Not to mention the inviting food stalls.

Sanjay Gandhi National Park (Borivali National Park)

110 sq. kms of protected area, this is the largest reserve forest in the midst of a sprawling metropolis anywhere in the world, with leopards, peacocks, deer, monkeys, birds and reptiles all sharing space in their natural habitat' The main draw of the park is the lion safari and a toy train for going around. A Welcome change from the crowded metro, it's also a favourite picnic spot for families in the weekends.



Kanheri Caves-

These are glorious examples of rock-cut Buddhist architecture found in ancient caves that are a marvel by themselves.



Elephanta Caves-

These ancient caves situated on an island just 9 kms. adrift of the Mumbai harbour in the Arabian Sea are marvels by themselves. Carved from rock face, these caves are an ideal tribute to the Maurya Dynasty that ruled there. The caves contain magnificently sculpted statues depicting 'Shiva' in various forms and facets. The most famous being the 'Maheshmurti' where Shiva takes the form of the Creator, the Preserver and the Destroyer. This place is also a favoured picnic spot for Mumbaikar. An hour's launch ride away from the Gateway Of India.



Mahatma Phule Market (Crawford Market).-

Located near the Chhatrapati Shivaji Maharaj Terminus, is Mumbai's largest fruit and vegetable market.



Brihanmumbai Municipal Corporation –

This 100-year old colonial building apposite Chhatrapati Shivaji Maharaj Terminus, houses the various administrative functional departments of the city of Mumbai.



Times of India Building –

Next to Municipal Corporation, this is the office of the Times of India Group, one of the largest publication houses in this part of the world.



Nehru Planetarium and Science Centre.-

Near Haji Ali, this expanse is the place where scientific the technological shows take place throughout the year. The science centre is a powerhouse of scientific information and knowledge.



Siddhivinayak Temple –

A few kms away from Nehru Planetarium and Science Centre, is this splendid temple of Lord Ganapati or Siddhivinayak, made of white marble. People come here from over Mumbai and even from others parts of the State to worship especially Tuesday is considered the most auspicious day of the week to visit this temple when long serpentine queues from outside the temple from wee house of the morning.



Mount Mary Church.-

A sacred place where the revered Madonna of Mount Mary stands. Large crowds comprising not just Catholics but people from all communities come here to pay obeisance. A special feature is the annual fair when the entire area comes alive with people, festivity, music and games for 15 days.



Mahalaxmi Temple is one of the most famous temples of the city of [Mumbai](#), India. It is dedicated to [Mahalakshmi](#) the central deity of [Devi Mahatmyam](#). The temple was built in 1831 by Dhakji Dadaji (1760–1846), a Hindu merchant.



Atal Setu- Mumbai Trans Harbour Link (MTHL)-

India's longest sea bridge has six-lane and is 21.8 km long with a 16.5 km sea-link. This is the 12th longest sea bridge in the World. This bridge will reduce distance between Mumbai and Pune Expressway. It provides connection to areas like under construction Navi Mumbai International Airport.

**Bandra-Worli Sea Link-**

This is a 5.6 km long, twin 4-lane [cable-stayed bridge](#) built using state-of-the-art segmental technology in the Arabian Sea. This bridge connects links [Bandra](#) in the Western Suburban of [Mumbai](#) with [Worli](#) in [South Mumbai](#).
